SURIA CAPITAL APPOINTS NEW CHAIRMAN AND CHIEF FINANCIAL OFFICER

Suria Capital Holdings Berhad is pleased to announce the appointment of Tan Sri Ibrahim Bin Menudin as the new independent and non-executive Chairman of Suria Capital Holdings Berhad effective 28 May 2018. The appointment came into effect following the resignation of Datuk Faisyal Bin Datuk Yusuf Hamdain Diego who chaired the Board since 2013. This has been Tan Sri Ibrahim's second appointment as the Chairman of Suria Capital. His first appointment was from 2002 to 2012.

Tan Sri Ibrahim brings along more than 30 years of extensive experience in the corporate world. He was once the Group Chief Executive Officer of Malaysia Mining Corporation Berhad from 1986 until October 2001 and Chairman of Malaysia Smelting Corporation Berhad from 1985 to 2001. He was previously a Director of SapuraCrest Petroleum Berhad. He became the Special Advisor to the Chief Minister of Sabah in 2002 until 2004. He had served the State Civil Service as the Accountant General of Sabah from 1976 and 1979 before joining the State's Bumiputera Investment Fund as the Chief Executive Officer until 1985.

Tan Sri Ibrahim graduated with a Bachelor of Commerce from University of Western Australia and is a Fellow of the Institute of Chartered Accountants in Australia, a member of The Malaysian Institute of Certified Public Accountants and the Malaysian Institute of Accountants.

Meanwhile, Suria Capital Holdings Berhad has also appointed Noorida Baharuddin as its new Chief Financial Officer effective 14 May 2018.

Prior to joining Suria Capital, Noorida was the Chief Financial Officer of Perbadanan Insurans Deposit Malaysia (PIDM) after serving as its Chief Internal Auditor.

She started her career with Pricewaterhouse and had worked with two regulatory bodies, namely Securities Commission Malaysia and Labuan Offshore Financial Services Authority; and with Permodalan Nasional Berhad, Malaysia Airlines System Berhad, as well as an attachment with the Islamic Financial Services Board.

Noorida holds a Bachelor of Business degree in Accounting from the University of Tasmania, Australia and a Bachelor of Law degree from Universiti Teknologi Mara (UiTM), Malaysia. She is a Fellow of CPA Australia and a member of the Malaysian Institute of Accountants. Noorida is also a Certified Financial Planner with the Financial Planning Association of Malaysia and a Chartered Member of The Institute of Internal Auditors Malaysia.
